Directive (EU) 2015/863

Dear Valued Customer,

With respect to all materials used in our Value Plastics and LinkTech line of products, our material suppliers certify that no materials contain any of the banned or restricted substances above the allowed thresholds, and therefore are in full compliance under the Directive (EU) 2015/863 of the European Parliament and of the council of March 31, 2015 (commonly referred to as "RoHS"), with one exception noted below. Any trace amounts of such substances are fully within the allowable limits. The maximum permitted concentrations in non-exempt products are 0.1%, (Cadmium 0.01%)

• Non stainless-steel metallic components (e.g., PTF and Panel Mount Nuts, and LinkTech 20CB series and 40CB series products) may contain levels of Cadmium and Lead above RoHS allowable limits.

RoHS now restricts 10 substances:

- 1. Lead (Pb)
- 2. Mercury (Hg)
- 3. Cadmium (Cd)
- 4. Hexavalent chromium (Cr⁶⁺)
- 5. Polybrominated biphenyls (PBB)

- 6. Polybromiated diphenyl ether (PBDE)
- 7. Bis(2-ethylhexyl) phthalate (DEHP)
- 8. Butyl benzyl phthalate (BBP)
- 9. Dibutyl phthalate (DBP)
- 10. Diisobutyl phthalate (DIBP)

The restriction of DEHP, BBP, DBP and DIBP shall apply to medical devices, including in vitro medical devices, and monitoring and control instruments, including industrial monitoring and control instruments, from **22 July 2021**.

On July 22, 2019 the RoHS Directive was updated and Category 11 was added. Category 11 refers to electrical and electronic equipment. The Value Plastics and LinkTech consumables are non-electronic and therefore are out of scope.

Please be informed that Nordson Medical relies on information provided by our suppliers and vendors. That said, we do not test or analyze these materials for the specified regulatory requirements. Ultimately customers must make their own determination that their use of our product is safe, lawful and suitable in their intended applications.
